

# Leah M. Sample July 19, 1923 - February 21, 2019

Leah Sample was born in Blue Hill at the nearest hospital to her home in Brooklin, Maine. Leah went through the Great Depression in her early years, but she acquired a lot of managerial skills that served her well throughout her life. She graduated as valedictorian of her class from Brooklin High School at age 15. She went to Eastern State Normal School in Castine, Maine to become a teacher.


Leah had a passion for community involvement. When she and her second husband moved to Boothbay Harbor in 1956 she made herself at home by volunteering in the community. She was a library volunteer, classroom leader at the elementary school, leader of both Boy and Girl Scouts, Garden Club President, member of St. Andrews Auxiliary and Advisory Board, Congregational Church volunteer and co-founder of "Meals on Wheels" in the early 1970's.

In the late 70's you would find Leah working at Fisherman's Wharf as hostess and desk clerk. A lifelong dream was fulfilled when she received a bachelor's degree in English from the University of Southern Maine in 1988. She taught GED classes and wrote a children's book, "The Summer of Jay," which was published in 2005. Leah worked for the Town of Boothbay Harbor from 2000 to 2006, as Deputy Town Clerk.

In 2014, the Boothbay Harbor Board of Selectmen honored her with the Spirit of America award for her many years of community service.

Leah Sample loved Boothbay Harbor and it showed in all she did. She is missed.

## **Board of Selectmen**

To the Residents of Boothbay Harbor: Our town is truly a wonderful place to live and work. It has been an honor to serve our community again this past year. The preceding 13 months have been marked with elements of the familiar, and yet much change.

In May 2019, residents passed all proposed budget warrants, maintaining a nearly flat mil rate, at our town meeting. The majority approved a series of ordinances for the Harbor's East Side designed to promote economic development while protecting the working waterfront. Select Board member Michael Tomko was re-elected, and Ken F-Fitch was elected to the Board.

In the fall, we accepted our long-time town manager's resignation and, after a thorough nationwide search unanimously selected Finance Officer Julia Latter as our new town manager. Julia's roots in our community run deep and her thorough understanding of the workings of a municipality are significant assets.

This last year, we celebrated Ms. Edna Greenleaf's 100th birthday at the St. Andrews Village, with the Boston Post Cane award.

The downtown waterfront bustled with excitement throughout the year, with Windjammer Days, welcoming the squarerigged ship Nao Santa Maria, hosting numerous local regattas, and holding the 8th annual Harbor Fest celebration. The Christmas Season sparkled with the Holiday Harbor Lights Festival, fireworks over the Harbor, and the successful fourth year of Boothbay Lights, our companion town event to Gardens Aglow as visitors were welcomed with thousands of lights and numerous shops, restaurants and hotels open for business.

Sound fiscal management has once again been the hallmark of the Select Board with a clean audit that affirmed the Town's sound management of taxpayer revenues through careful and responsible budgeting. Effective leadership by our department heads and thoughtful work of town employees will ensure we complete our fiscal year on track.

Additionally, your Select Board continued to work with economic and community development initiatives. Our historic footbridge remained top priority of the board, as we partnered with community members to review potential designs and upgrades. Research and analysis into the condition of the existing piling structure revealed a good foundation on which to renovate the superstructure.

The Harbor's rich history will come to life this summer with the new Museum in the Streets walking tour. A trail of historic structures and places highlighted by descriptive signage will lead individuals across both sides of the harbor and honor the legacy of our historic town.

Progress on economic development continues with the work of our Broadband Committee, which recently completed a two-town analysis of all existing broadband services. Working jointly with Boothbay, and potentially our other peninsula towns, the Committee is striving to obtain high speed internet access to all business and residents.

As we enter Summer 2020 with the uncertainty of the COVID-19 pandemic, we take comfort in the resourcefulness and vitality of our community and its residents. No matter what issues we experience in the months ahead, the warmth and generosity shared between members of our town will allow us to persevere and flourish.

We take pride and offer thanks to all our town employees and committee members who have worked hard and dedicated themselves to serving our community, preserving our town, and preparing us for a bright and exciting future.

# Town Manager

Many of the town's departments saw change over 2019. We said farewell to Clyde Burnham, after 16 years with our public works department and welcomed Sawyer Alley to the public work's crew. Jeff Lowell was appointed as our Harbor Master in August, replacing long time Harbor Master Nick Upham. This year I'm proud to report that Officer John Braley graduated in the top ten percent of his class from the Basic Law Enforcement Training Program at the Maine Criminal Justice Academy. Town Clerk Michelle Farnham, after an extensive 3-year training program, graduated from the New England Municipal Clerks' Institute, pursuing her certification as a New England Town Clerk. Additionally, Trish Fallon became certified as a Deputy Town Clerk through the Maine Town and City Clerk's Association. Congratulations on their accomplishments! Finally, I am pleased to welcome Kathleen Pearce as Boothbay Harbor's new Finance Officer.

May, 2019, saw the culmination of two years' worth of work by municipal boards, staff and many volunteers in the formal adoption of two new zoning districts on the east side of the harbor. We also welcomed Ken Fitch to the Board of Selectmen and said our goodbyes to Russ Hoffman. Russ's positivity and commitment will be missed and we wish him well in the future.

Our annual financial audit was completed for fiscal year ending 2019, reporting that the town is in fiscally strong financial shape. As we approached this year's budget creation, department heads worked closely with administration to evaluate and streamline their budgets, allowing for accurate forecasting, and creating a more comprehensive foundation for capital projects.

2019 was also filled with many examples of camaraderie and support that our town shows for their neighbors, friends, and family. On Halloween, due to unforeseen weather conditions, municipal staff, area businesses, civic organizations and volunteers transformed our fire department into a fun filled Halloween oasis, complete with an indoor costume parade, as well as candy and gifts for the children. I was very proud to be asked to be involved with this year's Set for Success, a program that continues to grow, improve and help provide our children by giving them the tools necessary to excel.

In closing, I would like to express my sincere gratitude for allowing me to serve the town that I love. I look forward to all that we can accomplish together. For anyone that wishes to stop and talk with me, my door is always open.

## **Code Enforcement Officer**

In May, 2019, the Town voted to adopt two new zoning districts. The Limited Commercial/Maritime District, and the Working Waterfront District, both located on the east side of the Harbor. Since the adoption of the new districts, a private group, Boothbay Harbor Waterfront Preservation, raised money to buy the former Cap'n Fish's Motel property, with plans to turn it into a public park. The group has continued with design work, and will likely come before the Planning Board in 2020, to begin the site development process. I know many are looking forward to seeing the park open, and having public greenspace along the Harbor's waterfront. I encourage all who are interested to attend Planning Board meetings, and become involved as the process moves forward.

Also, in 2019, we welcomed a few new businesses to our Downtown Business District. The downtown commercial area continues to change and evolve, demonstrating the popularity of our town and the region, and the dedication of our local business owners, who work very hard throughout the year to make our town so inviting.

Both residential and commercial construction and development continue to thrive, and can be seen in almost every neighborhood. New homes, new commercial structures, new hospitality buildings; the work is everywhere. Local groups have also been focusing their efforts on ways to provide affordable workforce housing. One such development was brought forward during the summer of 2019, but eventually other locations were pursued. As our area's housing needs change, I anticipate that we will have many opportunities to review our zoning, discuss ways in which to encourage housing, and work with local groups and developers to find long term housing solutions.

# **Boothbay Region Historical Society**

During 2019, our 52nd year, we enjoyed the support of both Boothbay and Boothbay Harbor voters. The funds voted by townspeople helped us to fulfill our purpose of preserving and increasing knowledge about our region's past.

We held regular year-round hours at the museum in Boothbay Harbor on Thursdays through Saturdays, 10 a.m. to 2 p.m. Over 1,000 people came to the museum, about two-thirds of them to buy books and photos or in search of specific information about families, houses, businesses, vessels, and other historical matters. The balance browsed through the six rooms of local artifacts. We sent out two newsletters and monthly electronic updates. We had four speakers for our open house events. We had a bake sale and a silent auction in addition to our fall cheese sale held at the Boothbay Railway Village, and a cheese and bake sale in our front yard. In December we opened our World War I uniform exhibit and our community uniforms from the mid-1900s.

We provided news items and articles on local history to the townspeople and others through the *Boothbay Register*. We are an active research facility, assisting people locally in their search for information on family, houses, vessels, and places. We also carry on correspondence with people all over the country and abroad who have an interest in Boothbay region history, and when asked we help the town offices with research.

We have many active volunteers who donated more than 2,000 hours of work this year. Some of their projects were: preparing exhibits, organizing public events, computer data entry, checking the order of photos and documents, manning the building, making repairs, helping with property clean up, helping with mailings, and documenting new collections and artifacts. Our building has undergone much needed repairs to the roof and front windows and inside walls.

The sources of our income this year were: donations by individuals and the towns; one grant; membership dues; and sales of books, maps, papers, and photographs.

Our holdings of artifacts, collections, and documents increased by three linear feet of documents, 15 books, approximately 150 photographs or images, and more than 28 artifacts. Among the donations were an Indian Pack Basket made by the Ranco family from Alfred Pinkham Sr and given to his son, the Fisherman's Festival trophy listing winners from 1978-1998 and a child's shoe found in the wall of the Hodgdon house on Hodgdon Island.

We thank the townspeople for their willingness to contribute to the preservation of local history.

# **Boothbay Harbor Memorial Library**

2019 was so busy and fun. In the circulation department, we lent out 30,642 items (up 5% from last year); digital checkouts increased 7% to 5,006 items; discount museum pass use almost doubled: passes were used 219 times in 2019. The Orion StarBlast telescope and GoPro cameras were borrowed 9 and 8 times respectively. Volunteers delivered 278 books to our homebound patrons.

On the tech side, in June we upgraded the library's firewall, and in September increased our upload/downloads speeds to 200mbps.

Also in September, the Maine State Library launched the Statewide Reciprocal Borrowing Pilot, and BHML signed on for the one-year pilot. During the pilot, anyone with a valid card from a participating library can visit other participating libraries and check out materials in person (walk-in borrowing).

In June, the BRES third graders visited and got library cards. In November, sophomore students came to the library for expert research tips and support finding sources for local history topics. The success of the afterschool Minecraft Club inspired two new afterschool clubs: LEGO Club for 1<sup>st</sup> and 2<sup>nd</sup> graders and Coding Club for 5<sup>th</sup> and 6<sup>th</sup> graders. In October, for the launch of the LEGO club and the re-start of Minecraft Club, the school bus dropped off 40 students for the clubs' kickoff!

Again during the summer, BHML hosted volunteer Jane Watkins to guide rising seniors through the college Common Application. This year we added SAT prep with Assistant Director Desiree Scorcia.

All in all in 2019, BHML offered 317 free public programs that were enjoyed by 4,980 people. 257 of these programs were for children, and 60 programs were geared towards adults. February – June we again hosted the Maine Humanities Council "Let's Talk about It" book club.

In April, we hosted the 3rd Annual Earth Day Fest; in June we kicked off summer reading at Windjammers for Wee Mateys, and in July we put on the 16<sup>th</sup> Annual Books in Boothbay, co-hosted by the Railway Village; and a free children's jazz concert at the Shipyard in Boothbay Harbor, co-hosted by the Boothbay Sea & Science Center. Summer reading wrapped up in August, and 101 children participated in BHML's summer reading program.

The 2019 Halloween Parade threw us all for a loop! Due to predicted storm conditions BHML, the Police Department, Public Works, Fire Department, local businesses, and the Town Office worked together to bring the parade indoors. With less than 24 hours' notice, we got the message out that the parade was on—at the firehouse! Over 25 businesses and community members passed out candy; and BHML library trustees served warm apple cider to folks waiting in line to trick-or-treat – teaching us that this indoor Plan B did not keep everyone out of the rain!

Once again, thanks to the generosity of the donations made to the Friends of the Library Used Bookstore, BHML was able to give out a wrapped book to every child that came to the library during Santa's visit to the harbor.

In 2019 the BHRCC started to restructure itself to better suit the needs of our community in the growing 21st century.

In 2019 we distributed 95,000 Region Guides and Maps to all the AAA offices throughout New England as well as Chambers of Commerce statewide, the Maine Tourism Association, Maine Turnpike Visitor's Center, the Portland Jetport and Portland Visitor's Center. In the coming few years, we aim to be able to bring this information to visitors in more digital formats as well. We provided reduced cooperative advertising opportunities in Maine Invites You. Our website visitation was 600,000 annual views. Our weekly newsletter, "Chamber Connections" shares information within our membership and our monthly newsletter goes out to over 7,000 visitors.

Locally: The chamber works with the Board of Selectmen and town managers from each of the towns in our region on initiatives that promote economic development including public restrooms, water, parking, health care and other issues including becoming a "Certified Business Friendly" region.

Regionally: The chamber is working with Mobilize Midcoast Maine which is a local leadership driven initiative that maps regional assets and industry cluster value chains which will become the foundation for a statewide Community and Economic Development Strategy. The chamber is also a member of Midcoast Chamber Council (MC3) which promotes the region with an information hotline, SeeLife! MidCoast Guide, a website, Facebook page, Bi-weekly blogs, tweets, print ads, posters, information kiosks and displays.

Statewide: The chamber works with the Maine Sports Commission whose primary goal is to strengthen efforts to attract national and regional sporting events. The chamber also works with the Governor's office, the Maine Office of Tourism, CruiseMaine and other entities to promote the region.

In 2020 in line with the restructuring started in the previous year, the BHRCC held an open house where we rededicated ourselves to the community. At the open house we announced several changes intended to increase the overall value our members get out of their memberships. All members get 1 free E-Blast to 10,000 visitors, all restaurants and accommodation will be on our regional chart, free marketing & design consultation and enhanced website listings. In addition to that we will be looking to restructure our pricing model for 2021 to be more considerate of all the businesses.

Thank you to all the businesses, organizations, teachers, individuals and town officials whose continued support of the Boothbay Harbor Region Chamber of Commerce help make this region strong.

# **Boothbay Region Ambulance Service**

Greetings to the residents of the Town of Boothbay Harbor- please accept this report of operations for our service to your community. We take our role in service to Boothbay Harbor seriously and it is our honor to continue to serve you. B.R.A.S. is licensed at the Basic EMT level and permitted to provide Paramedic level care, community paramedicine and paramedic interfacility transfers. While providing emergency medical service is not unique, the needs of the communities we serve are diverse and, at times, pose challenges. Our call volume is diverse- we respond to the unique needs of a aging population while at the same time serving our younger population experiencing substance abuse disorder and everything in between. We train to respond to our island communities, perform water rescue jointly with the US Coast Guard and join with you to serve the swell of seasonal visitors.

Our service is staffed with two crews around the clock and transport to the local emergency departments. We assist St. Andrew's Urgent Care and the Boothbay Region Health Center by responding to those facilities while their staff assess and, in some cases, start treatment. In between emergency calls we provide interfacility transfers. A breakdown of 2019 is as follows:

Total responses: 1,461 Boothbay Harbor: 733 Average Response time: 8:56

Destination- Miles ED: 547 Destination Mid-Coast ED: 259

Looking ahead to 2020 we will begin the planning phase of replacing one of our older ambulance's in accordance with our replacement and useful life schedule. Our vehicles are well-maintained- however the unique nature of their use and the complex electrical systems limit the useful life of each ambulance to about 7 years or 125,000 miles. We are also pleased to place into service our fully-functional simulation lab. To our knowledge we are the only ambulance service in Maine who has this capability. We are grateful to the community for their generosity to provide this. We are also welcoming this center to our neighboring services so that we can collaborate and learn together. Finally, we continue to provide community paramedicine services to those who need additional medical assessment. We intend for this service to keep our residents safe and at home!

On behalf of the Board of Directors and the Service we extend a sincere THANK YOU for your generosity and support of our service. We strive to better ourselves at each opportunity and provide the Boothbay Region with the best care possible.

## **Sewer District**

I am pleased to offer this report on behalf of the Boothbay Harbor Sewer District. As always, let me begin by saying thank you to the citizens of the Boothbay Region, who have generously given of their resources to ensure that your District remains among the finest in Maine. The District certainly benefits from a strong user base, but beyond that, we benefit from a strong citizenry. From dedicated employees who live in the region, to cooperative municipal departments, and most helpful contractors; our customers and visitors are provided opportunities to live in and enjoy one of Maine's most scenic regions, and we thank you for your continued commitment to the District.

This year saw the addition of Riley Mitchell as a new employee. Riley filled the vacant collection position and will be learning to operate the plant as well. Riley now brings the District to a full and cross-trained staff.

The District continues to plan improvements in your treatment and collection systems. As in the past, the next several years will continue to be busy. The Trustees are into their fifth year of their capital improvement plan. The planned improvements will include planning/funding for pipe re-lining on the west side of Town, inflow and infiltration reduction, manhole rehabilitation, treatment plant systems upgrades, and two pump station upgrades. This year's major improvements to your system and other accomplishments included the following:

- Completion of the Odor Mitigation Study for the treatment plant,
- Procuring an Odor Scrubber for the Centrifuge area (Phase 1 of 4),
- Commencement of the Replacement and Extension of the Route 96 Sewer Line.
- Planning for the Replacement of the Plant Influent Pumps and Aeration Blowers,
- Secured a grant from Efficiency Maine and replaced all the plant and office lighting,
- The District Charter was amended to incorporate all the provisions of the Sewer District Enabling Act.

The District Trustees continue to lead the District through their strong work ethic, strong leadership style, and fiscal responsibility. Because of this leadership, the financial position of the District is strong. The District was able to secure over \$300,000 in grant funds toward projects. Credit is given to the careful management of spending along with consistent and fair implementation of the District's sewer use fees.

I would like to take a moment to express my appreciation and thanks to the entire District Staff for their friendliness and professionalism as they perform their work. These folks work very hard on your behalf, and their efforts do not go unnoticed. What a great Team! And finally, I sincerely thank you, the citizens of the District, for the confidence you have placed in all of us as your Boothbay Harbor District. It is an obligation that each one of us takes very seriously.

# **Public Works**

Last winter started out with little snow on the ground. Warm and cold temperatures gave us storms that started out as snow changing over to sleet and rain. The rain at the end of the storms, with returning cold, caused several issues with ice overflowing the ditches and extending into the roads. This led to a more difficult after storm clean up, and the need to continuously scrape off the ice built on the roads from water overflow. Our last snow storm of the year was April 8<sup>th</sup>. Following the storm was a very rainy and wet spring.

In the summer, the town purchased a cycle bar mower for the Kubota. The cycle bar gives us the ability to start roadside cutting sooner than normal and will allow us to keep ahead of the continuing growth on the roadside throughout the summer.

Public works replaced a heaved and broken culvert on Bayville Road. After the culvert was replaced, we dug out the ditch along the side of Bayville Road allowing better water flow during heavy rain events. Ditching was also done on Sunset Road and Wall Point Road where icing was a big issue during the winter.

Over the summer, the crew graded and seeded in the area around the pickleball and basketball court. In the fall we began the vegetation phase by planting trees in the lower parking lot. At the same time, we set a sloped grade from the sidewalk by the congregational church parking area, taking away the risk of a pedestrian falling off the side of the walkway straight down to the parking lot. Trees and plants were planted as a buffer between the parking lot and sidewalk and to beautify the area. Emery Lane was repaved halfway to St. Andrew's Village. This section of road was deteriorated in several locations. The sidewalk was removed, raised and re-graded.

Finally, I would like to congratulate public works employee Clyde Burnham on his retirement, and thank him for his dedication and hard work given to the Town of Boothbay Harbor over the last 16 years. Many thanks to the community, Town Manager, and Select Board for their continuing support.

# **Boothbay Region Water District**

2019 marked the end of an era at the Boothbay Region Water District. In May, after 59 years of faithful service, Chairman of the Board and lifetime Boothbay Harbor resident, Harry L. Pinkham retired. Over Harry's tenure he was a driving force in creating a true regional water utility. The list of initiatives and accomplishments Harry presided over during his distinguished career, all to the benefit of not only the residents of Boothbay Harbor, but the residents of the region as a whole, are to numeral to list here. Suffice it to say, whether you realize it or not, the legacy Harry left with regard to improving the water supply and safeguarding the public health of the region, will be felt for decades to come.

During 2019 the district was very busy in many areas of operation. Some of the projects and efforts accomplished are as follows: completed numerous watershed protection projects along Adams Pond in Boothbay, funded in part with grant money from the Maine Department of Health and Human Services as well as the Maine Department of Environmental Protection; replaced approximately 900-ft of substandard water main along Logan Road in Boothbay Harbor with a new 6" high density polyethylene (HDPE) water main; made two land purchases in the town of Boothbay, one of 5-acres and one of 3-acres, of highly important watershed protection land; Completed a 300-ft, privately funded, water main extension along Massachusetts Road in Boothbay Harbor; Installed seasonal water main on Sawyers Island Bridge, increasing water pressure on Samoset Road in Boothbay and Boothbay Harbor; replaced two worn out 12-inch raw water check valves; perform mid-level overhaul maintenance for both filter trains and pull and repair two of the district's six twelve-inch vertical turbine pumps at the Adams Pond Treatment Plant; continued emphasis on leak detection, equipment maintenance and unequaled performance (i.e. value to rate-payers) and added 42 new customers.

Not to be overshadowed by Harry Pinkham's departure, the board saw another departure from the board, that being Boothbay representative, Jon Lewis after three-terms of exemplary service. Jon's intelligence, worldly knowledge and level-headed leadership will be greatly missed and the board is very thankful for his exemplary service.

In March, the voters of Southport re-elected Gerald, "Gerry" Gamage as their representative, who was elected by the board to succeed Harry Pinkham as Chairman. In May, the district welcomed two highly qualified newcomers to the board with Alan Bellows elected in Boothbay to serve as a Boothbay representative, and Merritt Blakeslee was elected in Boothbay Harbor to represent the citizenry in that municipality. During the first meeting in May the board elected Smith Climo (Southport representative) Vice-Chairman board; Kevin Anthony (Boothbay representative), District Clerk; and Nell Tharpe (At-Large representative) Treasurer. Rounding out the board was David Tibbetts (Boothbay Harbor representative).

The Boothbay Region Water District, Board of Trustees meet the 2<sup>nd</sup> & 4<sup>th</sup> Tuesday of every month at 6:00 p.m. during daylight savings time and 7:00 p.m. during standard time at the district administrative office located at 184 Adams Pond Road, Boothbay Maine. The trustees value the publics' opinion and encourage the public to attend. # **Boothbay Harbor Fire Department**

The Boothbay Harbor Fire Department had two structure fires this year. The first fire came in late spring at an apartment building. Quick response made it possible to contain the fire to one room, stopping the spread to the rest of the apartments.

The second structure fire was a summer residence. This fire was extremely difficult to contain due to the construction of the residence. Firefighters were able to salvage much of the personal property for the homeowners.

We had several storms in the spring and fall which brought down trees and power lines. Some of these trees and lines ended up in the road requiring the department to block off through access on these roads. I would like to give a reminder that we block off these roads for safety reasons. The biggest reason being powerlines entangled in the tree or across the roads. Even though the power might be out in the area, and you do not see any sparks coming from down lines does not mean the power line is safe to touch or cross over with a vehicle. Home generators can send a back feed into those lines making them live. We have no way of checking the power lines and must rely on CMP to ground them, making removal safe. Please be safe and seek another route to your destination when you see the roads blocked. It is not only for your safety, but for the safety of the firefighters having to replace the barricades.

Remember to check the batteries in your smoke detectors every year and replace them whether you feel they are good or not. Building materials used today tend to burn faster and proper working smoke detectors give you the time needed to evacuate safely.

## **Harbor Master**

I was sworn in as Harbormaster on August 26, 2019. I had the beautiful end of the season to get accustomed to the boats, harbor procedures and the moorings located in the waters of Boothbay Harbor.

I am not new to the Boothbay Region. I lived and worked here from 1977 until 2012. I returned last June to be with family and now give back to the community that has always been good to me. The primary responsibility of the Harbormaster is to promote safety in and around our very busy and prominent harbor. This includes the enforcement of existing no wake zones, federal maritime laws and safe boating practices.

There will be increased attention to new and existing moorings, their placement, proper identification and maintenance. The pump out boat and the patrol boat will be available and active in the harbor.

Windjammer days this year have the added attraction of the coinciding Tall Ships visit to the Harbor. It promises to be a stunning event and a unique opportunity to enjoy our maritime heritage and spend quality time with family and friends in Boothbay Harbor.

I will have available USCG vessel identification stickers. I will encourage all boaters to attach these to unregistered dinghy's and kayaks. In the event one of these becomes adrift, it will aid in the identification of the rightful owner which will be essential in an emergency situation. This identification can save hours and resources in the event a vessel is located adrift, as well as save valuable search and rescue resources.

Before launching your vessels each season please be sure that you update your registrations and inspect all safety equipment and fire extinguishers. Take advantage of the USCG Auxiliary complimentary safety inspections.

I look forward to an enjoyable and safe season on the waters of Boothbay Harbor and look forward to meeting you all.





- Article 12 Voted to authorize the municipal officers to make final determinations regarding the closing or opening of roads to winter maintenance pursuant to 23 M.R.S.A. Section 2953.
- Article 13 Voted to authorize the municipal officers to dispose of any town owned personal property under such terms and conditions, they deem advisable.
- Article 14 Voted to authorize the municipal officers to carry forward any unexpended account balance, they deem advisable, provided that the account carried forward is used for the same purpose, and to fund any expenditure exceeding budget from the undesignated fund balance.
- Article 15 Voted to authorize the municipal officers to accept any state funds received by the Town and to appropriate any funds received for a particular purpose to that purpose. Funds received but not dedicated to a particular purpose are appropriated for such uses, terms and conditions as the municipal officers deem advisable.

# **Special Town Meeting Minutes November 5, 2019**

Meeting was called to order by Michelle Farnham, Town Clerk, at 8:00 a.m. on November 5th and the following action was taken:

Article 1 Nicholas Upham was elected moderator by written ballots and sworn into office by the Town Clerk, Michelle Farnham.

The following articles were voted on by secret ballot:

Article 2 Voted to amend Chapter 170, §170-101.12, Definitions "Height of a Structure" to include the following underlined text, addressing a previously omitted reference point to measure building height;

**Height of a Structure -** The height of a structure shall be measured from the mean original grade or the mean finish grade, whichever is lower in height, to the highest point of the structure, excluding chimneys, steeples, antennas and similar appurtenances that have no floor area. As used herein, the mean original grade is the average elevation of the ground at the downhill side of the structure where it is to be constructed before any grading or other alteration. The mean finish grade shall be the average of the finish ground at the downhill side of the structure after the construction and grading is complete.
