Resident \$50.00 per mooring - Any person who occupies a dwelling within the Town of Boothbay Harbor for more than 180 days in a calendar year, or the applicant pays boat excise tax or property tax to the Town of Boothbay Harbor.

Non-Resident \$100.00 per mooring - Any person who does not occupy a dwelling within the Town of Boothbay Harbor for more than 180 days in a calendar year, UNLESS the applicant pays boat excise tax or property tax to the Town of Boothbay Harbor.

Association/Club \$80.00 per mooring - Any dock, pier, wharf, float, floating business, or combination of such facilities that serves five or more boats and does not collect fees for moorings.

Marine Enterprise \$80.00 per mooring - Any dock, pier, wharf, float, floating business, or combination of such facilities that serves five or more boats and that has moorings for the express purpose of rental.

PLEASE READ ALL INFORMATION BELOW BEFORE SIGNING:

This form must be completed and returned to the Town Office with the required fee by June 30, 2021.

A late fee of \$15.00 will be assessed for each mooring paid after June 30, 2021.

Moorings MUST be identified with the assigned mooring number in a three-inch block print in a contrasting color. Failure to comply with the above instructions could result in the loss of all mooring privileges. Incomplete applications will not be processed and will be returned. If name or address changes from that given on the application, please notify the Town Office. I acknowledge that I am familiar with the Boothbay Harbor Port Regulations and agree to abide by them. Furthermore, I certify that the information provided above is true and accurate.
