\_\_\_\_\_ **Marine Enterprise - \$80 per mooring:** Any dock, pier, wharf, float, floating business, or combination of such facilities that serves five or more boats and that has moorings for the express purpose of rental.

\_\_\_\_\_ **Non-Resident - \$100 per mooring:** Any person who does not occupy a dwelling within the Town of Boothbay Harbor for more than 180 days in a calendar year; **unless the applicant pays a boat excise tax or property tax to the Town of Boothbay Harbor.**

\_\_\_\_\_ **Association/Club - \$80 per mooring:** Any dock, pier, wharf, float, floating business, or combination of such facilities that serves five or more boats and does not collect fees for moorings.
